Minutes of the ESCP AGM 21 September 2017 – ESCP Berlin

1	PRESENT Refer to appendix 1
2	PRESIDENT'S WELCOME AND REPORT Emmanuel Tiret welcomed everyone to the AGM and said that as he had already presented at the President's Address earlier that day that his welcome would be brief.
3	MINUTES OF THE AGM The minutes from the AGM's in Dublin on 24 September 2015 and Milan on Thursday 29 September 2016 were approved.
4	PASSING OF SPECIAL RESOLUTION AND ADJUSTMENT TO ESCP RULES Eloy Espin Basany began by stating that any resolutions or adjustments to ESCP rules will be decided only by a show of hands. He went on to explain there had been a review of the Articles of Association and a Resolution put to vote in a General Meeting does not have to be a proposed or seconded. This would now be decided only by a show of hands. During the 2016 AGM in Milan, there were concerns raised by some members who felt that the rules of the Articles of Association were not being observed. At that last AGM it was decided that ESCP to pause the changes of the rules and review, and if any changes were to be decided, they would be decided at the AGM in Berlin. Legal advice was sought about how we communicate to members and ESCP was advised that we are conducting AGM meetings in the correct way. Those rules which were proposed last year are summarized as above. The audience were invited to show any objections to the proposed adjustments to the ESCP Rules. There were no objections, and members approved. There were changes to Articles of Association to be in line with the latest Articles of Association which date back to 2006. No objections received to changes in Articles of Association which were sent by email to all members on 9th August 2017. Members approved with a show of hands.

Eloy Espin Basany thanked the ESCP for the privilege of serving as Secretary for the past three years and especially thanked his past four Presidents Ronan O'Connell, Yury Shelygin, Stefan Post and Emmanuel Tiret. He also thanked all the Executive Members with special thanks to Peter Dawson, and the staff of Integrity Events.

8 TREASURER'S REPORT

Filippo La Torre delivered his presentation as ESCP Treasurer.

Filippo La Torre started by saying that ESCP has changed its outlook, and the society is investing funds in many activities. This is reflected in the budget and he outlined his priorities as Treasurer.

It was reported that the last year end showed a deficit of minus €355,000. He explained that this figure was justified due to investment in the society and highlighted the key areas; research/trials initiatives, education's fellowship programme, communications and face-to-face committee meetings. He reported the membership related expenditure is related to *Colorectal Disease* journal subscription and society administration. He highlighted that the provisional projected funds at 31.12.2017 would be around €871'300, and said that the conference profit of €115'000 would improve further since it was based on 1450 registrations and that this had been exceeded by 200. Conference registrations was at 1687 as of today.

He advised members of the projects and priorities as Treasurer

To Save Money:

- A revised speaker (and fee) policy for ESCP meetings
- 2017 and next non-conference budget finalization and accountability

To increase Income:

- Membership growth
- More profitable conference
- Generation of financial partnerships with key sponsors

Ronan O'Connell congratulated everyone on the success of the meeting. However he expressed concerns that society reserves are diminishing. He stressed that the Executive Committee should be very careful as it must be able to salvage this otherwise the Society's funds could disappear. Filippo agreed and said that ESCP are working very hard to avoid any further deficit.

Najib Haboubi highlighted that there has always been a strategy to increase membership growth and that the society is progressing in the right direction and asked whether there was any other new strategic approach to take into consideration. Filippo responded there needs to be more sponsorship with key sponsors. Najib Haboubi endorsed that, and questioned whether ESCP should consider increasing membership fees, freezing face to face meetings.

9 TRUSTEE'S REPORT

Giovanni Romano reported that the Executive and Council should be complimented on their work. He went on to say that there were some recommendations from the Trustees who had met earlier in the day with the Treasurer.

He said that overall the Trustees were very happy with the Committee work with the progression of the Society from the scientific point of view and all the expenditure which had been spent on the committees, fellowships and research initiatives are essential for the Society's investment. Their suggestion was to carefully monitor society expenditure and

	some of the proposals by the Treasurer had been well received. A further proposal was to increase the membership fee which was deemed as relatively low. Although there is room for improvement, he was cautious but confident that the balance can be easily adjusted next year.
	On Giovanni Romano's behalf, Emmanuel Tiret, proposed the reappointment of Trustees and the reappointment of Whitelaw Wells as ESCP Auditors. There was no objection and the reappointment was agreed by all members present with a show of hands.
10	INAUGURATION OF NEW PRESIDENT Emmanuel Tiret welcomed the new incoming President, Ethem Gecim, and invited him to address the members.
	Ethem thanked everyone for the support and trust as the newly elected President and advised that despite the financial situation, he feels confident for the future. He said that the committees are doing a great job and meetings are getting better and better.
	Emmanuel Tiret ended the presentation and said it had been a huge honour and a pleasure to be President.
11	CLOSE & DATE OF NEXT MEETING The next AGM will be held on Thursday 27 th September 2018 in Nice.



EDUCATION COMMITTEE UPDATE

THE AIMS OF THE EDUCATION COMMITTEE ARE:

To deliver high-quality, contemporary education for surgeons in training and practice, and for other allied healthcare professionals.

To educate, disseminate and accredit to the highest standard in Coloproctology across Europe.

As the leading European Society in Coloproctology, the scope of the Society has been further expanded towards educational content during 2017. This includes:

1. Further modification of the "Education Stream" at the annual meeting: in addition to activities targeted towards technical skills, decision making and clinical judgment (offered in sessions such as the Ultrasound seminar, the Expert video session, Authors' workshop, Best publications of 2016, interactive workshop, and the Expert round table session) a variety of pre-congress and post-congress "hands-on" workshops has been expanded. "TAMIS", "operative techniques for techniques for the prevention and repair of parastomal hernia", "Introduction to the treatment of perianal fistula and haemorrhoids" and "Colorectal laparoscopic skills" courses are now offered. All of these courses offer advanced hands-on experience, excellent faculty, and a good teacherattendee ratio.

2. Continuation and modification of the ESCP Fellowship Program: The spectrum of the fellowship has been expanded: a six-month fellowship especially for training in colorectal robotic surgery has been added. The society now offers:

- · 1 six-month fellowship esp. in robotic surgery
- · 2 six-month fellowships
- 4 three-month fellowships
- 1 three-month fellowship for non-EU members
- 4 two-to-four-week observerships
- 3 reciprocal travelling fellowships with international societies (the American, Japanese and Korean colorectal societies)

A new evaluation system of the fellowship activities is in development, as is a matching system for applicants and teaching centres.

 Complimentary registration is again available for up to 50 students at the annual meeting in September.

3. The area of activities "ESCP goes global" is continued:

- "Activities in Coloproctology around the Globe" are presented at a session during the annual meeting.
- A three-month fellowship dedicated to colleagues from outside Europe is now established.

4. The ESCP Website accommodates new educational content for members such as: Free member access to the electronic version of the new 2nd edition "Coloproctology", the European Manual of Medicine.

- The second edition was launched in spring 2017. The structure of the manual serves as a template for the educational resources and will be linked to various other ESCP resources, such as meeting presentations and keynote lectures.
- Free access to presentations and video material from the annual meeting.
- The educational content of the ESCP website has been overhauled throughout the year and newly structured to improve access to the educational resources, also available on the new App.

5. The ESCP App has been launched in September 2017:

The new ESCP App now offers easy access by hand held devices to the content of the ESCP website - including the Educational Content of the ESCP and it enhances connectivity amongst members.

Relevant online and social media presence is now ensured.

6. Several Masterclasses took place: in Katowice, Poland on October 6, 2016 in conjunction with the 11th Symposium of the Polish Club of Coloproctology focused on rectal cancer. Almeria, Spain on May 17, 2017, in conjunction with the National Spanish Society Annual Meeting on functional disorders. The next masterclass will take place in Budapest, Hungary on November 17, 2017, in conjunction with the biannual meeting of the Chapter of Coloproctology of the Hungarian Surgical Society and the Hungarian Society of Coloproctology on surgical management of colorectal tumours.

Based on the success of the Perianal Fistula workshop at the ESCP Meeting 2016 in Milan, a "Spin-off" course was invited to take place in conjunction with the Annual Meeting of the Turkish Colorectal Society, this took place in Antalya on May 18, 2017.

7. For the first time the educational stream of the annual meeting is UEMS CME accredited, as the entire scientific program.

8. A cooperation of the "New Technology Working Group of the Education Committee ESCP" and The New Technology Committee of the American Society of Colon and Rectal Surgeons led to a survey "Implementation of new technology". ACPGBI and the Australasian Colorectal Society participated. The results were presented at the Tripartite Meeting in Seattle at the ASCRS meeting held in June 2017. The results will also be presented at the ESCP meeting in Berlin. The survey looked at new technology with regards to rectal cancer treatment. Further work is planned to critically appraise new technology in the treatment of colorectal cancer.

Future initiatives of the Education Committee in 2017/2018 will include further development of year-round educational activities and educational resources of the ESCP website and its online use, especially via the ESCP App. ESCP masterclasses are offered as teaching modules to National Societies, and we aim to address the needs of Trainees and Experts in and outside of Europe to ascertain CME Credits for the societies educational activities and the build-up of the European School of Coloproctology, starting with dedicated educational activities relating to laparoscopic and robotic colorectal surgery.

ESCP SOCIETY/CONFERENCE APP

The ESCP app was formally launched on September 11 and has been widely downloaded. There have been several stages of feedback from the App Working group and Comm Comm to ensure the app reflects the whole Society.

Through the app, members can access the resource library (including the ESCP Manual) as well as all ESCP website content. Comm Comm will discuss (Thursday 21 September) revenue generating possibilities surrounding the app such as year-round sponsor banners, hosted sponsor content etc. A report will be provided to the Executive to agree on sponsorship opportunities.

Sponsorship of the conference section of the app for 2017 totalled $\[\] 9,000,$ more than twice covering the annual support fee for the whole app ($\[\] 4,100)$). Companies willingness to sponsor the app could signal a significant year-round revenue opportunity for the Society.

GRAYLING

Grayling were appointed in March to serve as ESCP's communications team. They have been heavily involved in the monthly topic project, were responsible for the increased volume of videos ESCP have produced and continue to seek opportunities to increase awareness of ESCP.

Another key aspect of their work has been looking at a longer term strategic communications plan for ESCP. A key aim is to make ESCP the go-to source for decision makers and those with an interest in coloproctology. Grayling and Comm Comm will continue to assess methods for doing so and identifying areas of strength to promote, and areas to improve on.

ESCP SOCIAL MEDIA

ESCP's social media channels continue to be one of our main channels of communication. Since April 2016, we have gathered almost 2000 additional followers on Twitter, 400 on LinkedIn and 200 on Facebook. Comm Comm initiatives like monthly topics proved very popular and there was a noticeable spike in online engagement throughout this project. The delivery of several short videos has seen visitors to ESCP's YouTube channel to increase 4-fold. Comm Comm have identified several monthly topic options from October 17 onwards and, with Grayling's input, continue to maximise the impact of this initiative.

ESCP have published promoted posts on Twitter and Facebook in the last year with positive results. While not suitable for every tweet/update; it is worth noting the success of promoted posts for bigger/specific topics. An example of this – we allocated a budget of €250 to promote the ESCP Manual of Coloproctology. As a result, this tweet easily had our biggest audience, became our best engaged with Tweet and had our highest number of clicks.

NICE 2018 VIDEO

Our last two conference videos (Milan and Berlin) have been very well received online. Filming will take place in Berlin for our Nice video. This will be in line with previous years' costs. Any member wishing to take part – there is still time! Go and see Graeme at the registration area.

The Regional Events Working Group is delighted to report on the last Spring ESCP event held in Almeria, Spain on 17 May 2017.

This 3rd ESCP Masterclass, organised in conjunction with the 2017 Annual Meeting of the Asociación Española de Coloproctologia, covered the topic of 'Pelvic floor disorders - prolapse and incontinence' and aimed to deliver 'from basic to expert management' messages.

A total of 200 participants attended the masterclass. The expert panel were able to efficiently cover the various aspects of these now better-known and frequent conditions of interest to coloproctologists. The introduction of the pre-test by the speakers and interaction with the delegates allowed for dynamic sessions and the consultant corner led to a lively case discussion.

With the agreement of the speakers, the power point presentations will be available on our website for ESCP members. We also aim to anonymously compile the post-tests answers to appreciate the progress in the understanding of these conditions and their management, potentially leading to a publication in Colorectal Disease, if approved by the Editorial Committee.

We do hope that this educational day has provided clues to the attending colleagues for their day-to-day practice. Some suggestions have been made to adapt the program after this first experience, for instance to detail more SNS indications and mode of action rather than too specialised technical aspects but all presentations were very well received and perfectly simultaneous translated.

Some of the members of the panel clearly recommended to re-use the the present template of masterclass in different countries for the benefit of national societies and served populations on this relatively new topic besides cancer, proctology and IBD. Notice will be forwarded to the Education Committee of the ESCP on that matter.

The REWG wishes to express its sincere thanks to our Spanish colleagues and the organising committee of their national society for allowing us to set this greatly successful ESCP Masterclass.

TURKISH WORKSHOP UPDATE

ESCP participated at this meeting with two expert speakers, this was very much appreciated and the workshop on fistula management was extremely successful. It demonstrates the interest to add this type of support to countries in the Educational portfolio of the ESCP.

8TH SYMPOSIUM COLORECTAL GAMES, HERAKLION, GREECE – 3-5 MAY 2018

An open application has been received from the Greek Society. This is still in discussion but it has to be noted that the program will not be discussed with our ad-hoc committee and that there are already several ESCP members that participate in this well-known meeting.

APPLICATION & SELECTION PROCESS FOR 2019 & 2020 MASTERCLASSES

This will be discussed in detail at our next REWG meeting in Berlin in order to find the best way to select the candidates for the coming years.

In summary, the REWG has by now set up a workable template for Masterclasses, that includes pre-, per- and post-event organisation and budget. Finding a topic, building a program with the local organisers, contact with the speakers, sharing information, managing the event within the educational goals according to ESCP aims, assessing the satisfaction of the attendance are now identified and established as cornerstones for a ESCP Masterclass success. The most difficult task still subject to last-minute change is to find and secure a sponsor for Masterclasses.

COLORECTAL DISEASE REPORT FOR ESCP EXECUTIVE

INTRODUCTION

The journal is officially recognised by Index Medicus and is listed on Medline. The Journal's Impact Factor stands at 2.689 (July 2017), an increase on the previous year which was highlighted in a various marketing campaigns. During 2016 an app was launched for the journal. This has been promoted via newsletters, print materials, and on the journal and surgery web pages on Wiley Online Library. There are currently 334 users who have downloaded the app.

REVENUE

Total revenues for the year were £288,459. This represents a decline on the previous year of approx. £47,000. Member revenues from AGCPBI members decreased by £12,000 although revenues from other affiliated societies, and institutional sales remained broadly stable. Non-subscription revenues decreased by just over £27,000 in 2016 due to a decline in reprint and supplement sales.

Total costs were £160,834 which represents a decrease of nearly 14% and this has helped reduce the impact the decreased revenues have had on the monies due to ACPGBI. After the deduction of ACPGBI member revenues and publisher's overheads (at 5% of revenue, excluding ACPGBI members) the profit to be shared is £90,656, of which the ACPGBI is due 50% ie £41,249.

ESCP CO - OWNERSHIP

The co-ownership offer is 50:50 with the ACPGBI. The President of ACPGBI will chair an enlarged Journal Committee of both organisations. The ESCP will have equal opportunities with ACPGBI to publish its guidelines in the Journal, at the discretion of the Editor-in-Chief.

Block member subscriptions equitable to both the ACPGBI and ESCP (currently the ESCP pays €35,000 annually for a block member subscription) are being explored but not finalised. It was agreed that all members of both organisations should be subscribers to the Journal, regardless of the organisation through which they were subscribing.

AECP

AECP has been approached by another journal (whose identity is unknown) offering an affiliation and provision of the journal to its members at a lower price than the AECP is currently paying for Colorectal Disease.

The Journal is handling papers from Spain no differently from papers from other countries, and Spain is well represented on the editorial team. Claire Dowbekin noted that the Journal would lose around £15,000 annually if AECP were to cancel its members' subscription. No further information is available.

EDITORIAL OFFICE

The volume of submissions in 2017 to date was comparable to that in the previous few years, in particular for Original Articles and Systematic Reviews. Most submissions had been received from the UK, followed in order of size by China, Italy, the USA and a number of European countries. The overall acceptance rate was 29%, although 17% for Original Articles alone. Professor Mortensen and

the editorial team had been 'raising the bar' to ensure that the Journal does not accept too many papers, with enough copy now in hand to publish through to the January 2018 issue. The team of Editors had been expanded to 20 over the past year, with a broad range of handling times and acceptance rates across the team. Time to first decision for all article types was a median of 10 (0-86) days, this partly reflecting the fact that Professor Mortensen triaged out many papers. Time to acceptance was a median of 30 (0-126) days. These figures are comparable to other clinical journals published by Wiley.

ON-LINE ONLY PUBLICATION

A decision about moving to online-only publication could be deferred to discussions with the ESCP in Berlin in September. It is important for Wiley's institutional sales team, which is on the verge of negotiating 2018 subscriptions for institutions, to know the Journal's publication format. Claire Dowbekin undertook to liaise with the sales team about this, to explore the potential impact of online-only publication on advertising revenue, and to explore the financial implications for 'print on demand' publication.

The year has ended with a record participation in the ESCP supported audit on Left Colon, Sigmoid and Rectal Resections. The preliminary audit results shall be presented in Berlin. The Cohort study committee has been pleased to announce one publication from the 2015 Right Hemicolectomy Audit by Colorectal Disease. The same journal has recently accepted a further paper on Crohn's disease. The publications are great successes of the collaborative, which has to date assembled three annual audits. As a channel of disseminating evidence, publications are part of the strategy to improve the impact of research for the benefit of patients.

Communication has been a key theme in the last year to increase the impact of research, as well as to improve the participation of surgeons in research. The International Trials Map has been launched on the ESCP website and your feedback would be welcomed. The Map will be a key point of reference for colorectal trials and enable wider participation.

In order to help our members, keep abreast of new publications, the Research Committee has launched an initiative to provide on a regular basis a summary of a paper that it judged to be of interest and significance. The publication of such summaries shall occur on a monthly basis and the Research Committee keenly invites the readership for suggestions.

The Research Committee is welcoming to Berlin a delegation of patients from across Europe. The involvement of patients through all stages of research from setting research questions to disseminating findings should improve the work of the colorectal

clinical community. We look forward to seeing you at the first patient engagement symposium on Friday morning.

As the activities of the Committee have grown, we welcomed three new members to the committee: Christianne Buskens, Quentin Denost and Steven Brown. Please approach any committee members with further research ideas.

In the last year, the ESCP has established a new collaboration agreement with Intuitive regarding robotic research and is developing a further collaboration with a second company. Going forwards into 2017/18, the committee has set itself ambitious targets to develop cohort studies. We look forward to working with the ESCP membership through the year.

4. PROJECT 2: Protocol: Evidence and consensus on follow-up after primary colorectal cancer - an analysis of existing guidelines in Europe

The study will follow three main steps, starting with a systematic search to identify potential relevant material to be included in the review. Following the search process is the selection of relevant literature and filtering of all irrelevant literature. Finally, a systematic assessment of the literature will take place. The assessment process will address the quality as well as the content of the included literature, and end up with a synopsis.

PURPOSE: Over the last decade, many studies were performed regarding treatment options for hemorrhoidal disease. Randomised controlled trials (RCTs) should have well-defined primary and secondary outcomes. However, the reported outcome measures are numerous and diverse. The heterogeneity of outcome definition in clinical trials limits transparency and paves the way for bias. The development of a core outcome set (COS) helps minimizing this problem. A COS is an agreed minimum set of outcomes that should be measured and reported in all clinical trials of a specific disease. The aim of this project is to generate a COS regarding the outcome of treatment after hemorrhoidal disease.

METHODS: A Delphi study will be performed by an international steering group healthcare professionals and patients with the intention to create a standard outcome set for future clinical trials for the treatment of hemorrhoidal disease. First, a literature review will be conducted to establish which outcomes are used in clinical trials for hemorrhoidal disease. Secondly, both healthcare professionals and patients will participate in several consecutive rounds of online questionnaires and a face-to-face meeting to refine the content of the COS.

DISCUSSION: Development of a COS for hemorrhoidal disease defines a minimum outcome-reporting standard and will improve the quality of research in the future.

6. PROJECT 3: Haemorrhoid treatments
