Minutes of the ESCP Annual General Meeting Held at The Convention Centre, Dublin, Ireland

on Thursday 25 September 2015

1 PRESENT

2 PRESIDENT'S REPORT

ESCP President Yury Shelygin welcomed everyone to the meeting. He thanked ESCP Past President and local organiser Prof Ronan O'Connell for his assistance in organising a successful 10th Scientific and Annual Meeting. He began his report by reflecting on ESCP's achievements and highlights from 2014/2015.

- 2.1 Pre-Congress Workshops: Prof Shelygin reported on ESCP's first Pre-Congress Courses, which had taken place the day preceding the Official Opening of the Annual and Scientific Meeting. The two courses, Laparoscopic Skills and Proctology Operative Skills Courses, had been popular and initial feedback from participants was very positive. He thanked ESCP Diamond sponsor Ethicon, for their support and the Royal College of Surgeons in Ireland for their kind hospitality in hosting the Laparoscopic Skills Course.
- 2.2 Inaugural ESCP MasterClass: Prof Shelygin reflected on the first ESCP MasterClass, in cooperation with the European Crohn's and Colitis Organisation (ECCO), and with the support of the Russian Coloproctology Association, as a very successful event. He said that the MasterClass, held in Moscow, Russia in April 2015, was an important meeting in Russia and in the coloproctology calendar due to its powerful scientific programme. Prof Shelygin also mentioned the use of simultaneous translation between Russian and English as an important feature in its success.
- **2.3 ESCP Dublin:** Prof Shelygin reflected on the success of ESCP's 10th Anniversary Scientific & Annual Meeting. The conference was the largest to date, with more participants than ever before. He felt that the strong scientific programme has attracted more participants, and had led to ESCP becoming a more powerful organisation. He went on to thank ESCP sub-committee members for their teamwork throughout the year, which has culminated in a very successful meeting.

Prof Shelygin concluded his report by calling on Secretary Eloy Espin Basany to lead the rest of the meeting.

3 SECRETARY'S REPORT

Eloy Espin Basany thanked Yury Shelygin and extended his personal welcome to members.

4 MINUTES OF THE AGM IN BARCELONA ON 25 SEPTEMBER 2014

Prof Espin Basany asked members if the minutes from the previous Annual General Meeting in Barcelona on 25 September 2014 could be approved. There were no objections and the minutes were approved.

5 IN MEMORY OF LATE ESCP MEMBERS

Prof Espin Basany expressed his sadness upon hearing of the passing of Prof Jean-Claude Givel and Prof Yehiel 'Chilik' Ziv. He reflected on their loyal support of the Society and sent his sincere sympathy and regards to the families of both Prof Givel and Prof Ziv.

6 ADJUSTMENT TO ESCP RULES

- **6.1 Formalisation of Guidelines Committee:** Prof Espin Basany asked all members present to formally ratify the Guidelines Working Group as an ESCP sub-committee. There were no objections from members present and the request was approved.
- **Formalisation of Nominations Committee:** Prof Espin Basany asked all members present to formally ratify the Nominations Working Group as an ESCP sub-committee. There were no objections from members present and the request was approved.

7 MEMBERSHIP UPDATE:

Membership Levels: Prof Espin Basany reported that there had been a 32% increase in membership levels within the last year. He showed slides (*appended*) to illustrate the growth in ESCP's regions. He said that this growth was a combined effort by the Executive Committee, sub-committees and members and thanked them all for their support.

- **7.1 Honorary Member Update:** Prof Espin Basany advised that honorary membership would be awarded the following day to Koutarou Maeda, Mike Parker, and Steven Wexner.
- **7.2 EBSQ Fellow Introduction:** Prof Espin Basany advised that ESCP members who are successful in the EBSQ examination will now be regarded as ESCP Fellows, and will receive one year of complimentary ESCP membership for the corresponding year ahead.

8 NEW WORKING GROUPS

- 8.1 EXTERNAL RELATIONS/WEBSITE COMMITEE AMALGAMATION (TO COMMUNICATIONS WORKING GROUP): Prof Espin Basany informed members present that the Executive Committee propose for the External Relations and Website sub-committees will combine to form a new 'Ad-Hoc' Communications Working Group, to be formalised as a committee next year. This new group will have cross-committee representation and will be chaired by Professor Per Nilsson.
- **REGIONAL EVENTS WORKING GROUP:** Due to the success of the inaugural MasterClass, Prof Espin Basany advised that a new cross-committee Regional Events Working Group has been formed, chaired by Professor Paul Antoine Lehur. This group will be formalised next year and will be responsible for organising localised events within ESCP, the second of which is to be held in Poland in October 2016.

9 SUB COMMITTEE REPORTS

Prof Espin Basany referred members to a separate document outlining sub-committee reports for Education, Research, Website, Guidelines, Membership and Journal which had been compiled in the interest of time, and were available at the registration desk (see appendix).

10 COMMITTEE APPOINTMENTS

- **10.1** Prof Espin Basany outlined the new Executive Committee appointments:
 - President in Waiting: the Executive nominated Professor Ethem Gecim
 - **Programme Committee Chair:** the Executive nominated Professor Anna Martling to succeed Professor Donato Altomare
 - Assistant Treasurer: the Executive nominated Professor Filippo La Torre to succeed Professor Paul Antoine Lehur as Treasurer in one year's time

These appointments were proposed by Stefan Post, and seconded by Giovanni Romano and agreed by all members present.

Prof Espin Basany thanked those stepping down from the Executive and thanked them for their commitment to the Society, and their hard work. He invited Ronan O'Connell, Past President, and

Donato Altomare, Programme Committee Chair, to the stage, and they were duly thanked by members for their dedicated service to the Society.

Prof Espin Basany outlined the new Ordinary Members of Council:

10.2 Regional Representatives:

- Western Regional representative: Karen Nugent was nominated to replace Joao Pimentel
- Eastern Regional Representative: Dursun Buğra* was nominated to replace Kaspars Snippe

10.3 National Representatives:

- Martina Lemmerer was nominated to replace Sebastian Roka as the National Representative for Austria
- Gunnar Baatrup was nominated to replace Peter-Martin Krarup as the National Representative for Denmark
- Geza Papp was nominated to replace Istvan Beszynak as the National Representative for Hungary
- Juan Garcia Armengol was nominated to replace Gervasio Salgado as the National Representative for Spain
- Leonid Bilianskyi was nominated to replace Volodymyr Andriets as the National Representative for Ukraine

There were no objections and the appointments were approved by all members present.

*After the Annual General Meeting it was noted that Dragomir Dardanov was the intended nominee for the Regional Representative of the Eastern region. He will assume office with immediate effect and will be confirmed at the next Annual Meeting in Istanbul.

10.4 ESCP UEG REPRESENTATIVES:

Prof Espin Basany confirmed changes to ESCP's UEG Representatives. From the end of 2015, ESCP representatives on the UEG Programme and UEG Education Committee will also represent ESCP at the UEG General Assembly. The changes are as follows:

- Giovanni Romano steps down in December 2015 as General Assembly Representative.
- Dieter Hahnloser will replace Willem Bemelman as ESCP's UEG Programme Committee representative with immediate effect.
- Harald Rosen will replace Najib Haboubi as ESCP's UEG Education Committee representative from January 2016.

Prof Espin Basany concluded his report by calling on Treasurer Paul-Antoine Lehur to lead the rest of the meeting.

11 TREASURER'S REPORT

Paul Lehur thanked Eloy Espin Basany and extended his personal welcome to members.

Year-end funds estimate: Prof Lehur gave an overview of conference and membership budget areas, which generate surplus funds for the "other" (special projects) and investment categories. He advised that there are now substantial funds in place and showed a projected funds estimate for the end of year 2015 of over €1m, increasing from the 2014 year end position of €1,190,000.

11.2 Budget update Dublin

Prof Lehur advised that whilst the original budget had projected a small profit of €22,000, due to increased sponsorship and registration levels, the meeting was now expected to yield a profit of approximately €230,052 which is an excellent result.

11.3 Categorisation of Budget: Prof Lehur explained that Integrity International fees were increasing due to the growing tasks of the Society. He informed members that ESCP's contract with Integrity International Events had recently been audited and approved by Mac Dolan & Associates Ltd and will be reviewed again in 2017 after another audit process.

Prof Lehur also advised members that ESCP are now seeking to invest funds. Prof Mike Parker, Prof Giovanni Romano, Prof Filippo La Torre and Prof Paul-Antoine Lehur, will oversee a review of the investment of funds twice yearly.

- **11.4 Istanbul preliminary forecast:** Prof Lehur proposed that that conference registration fees will remain the same as 2015, and ESCP anticipate over 1000 delegates at the conference. He also advised members that €60,747 had already been paid for the booking.
- **11.5** Future financial perspectives: Prof Lehur advised members of ESCP's mid-long term financial perspectives. He showed slides (appended) to illustrate how ESCP could distribute money to ESCP sub-committees. He added that the Research Committee had received Executive approval for €100,000 as a fund to recruit a Data Manager. In addition, he illustrated how the Society might now set aside funds for sub-committee projects given its healthy position, subject to them setting out a clear business plan proposal/objectives and budgets required.

He ended by assuring members of the Society's robust financial health, and looked forward to the year ahead. There were no questions, and the report was agreed by all members present.

Prof Lehur concluded his report by calling on the Chair of the Trustees Giovanni Romano to report for the Trustees.

12 TRUSTEE'S REPORT

Prof Romano began his report by paying tribute to late Trustee Prof Jean-Claude Givel, saying that his thoughts and sympathies were with his family.

12.1 Update on Trustee Changes:

Prof Romano informed members of the changes to ESCP Trustees. The changes are as follows:

- Central region: Thomas Schiedeck becomes Trustee and joins continuing Trustees Giovanni Romano and Torbjorn Holm
- Eastern region: Algimantas Tamelis is to demit office and be replaced by Evgeny Rybakov. Prong Rybakov joins continuing Trustees Tom Scheinin and Adam Dziki
- Western region: Mike Parker is to continue in office for a further 3 years, and continues with Trustees Sebastiano Biondo and Julio Leite

12.2 FINANCIAL & RISK Management:

Prof Romano also notified members that the Trustees were pleased with the Society's financial and risk management. He highlighted the external audit carried out in May had been an effective tool and the Trustees were very pleased and satisfied with the outcome.

13 INAUGURATION OF NEW PRESIDENT

Yury Shelygin welcomed Stefan Post as the new incoming President and invited him to address the members. Professor Post said that he was very happy to be elected as President of such a prestigious Society. He said that with the support of ESCP's Executive committee and subcommittees, he hoped it will be a very successful year.

14 APPOINTMENT OF AUDITORS

Stefan Post asked members to approve the re-election of Whitelaw Wells as Auditors to the Society, there were no objections and was agreed by all members present.

Yury Shelygin proclaimed the meeting closed.
